The buyer has a 48-hour approval period from date of purchase to take the Show Puppy to their Veterinarian to be checked. If the Show Puppy is not in perfect health, return Show Puppy to Tonya by the 3<sup>rd</sup> day of purchase (with the registration papers) and the buyer will receive a full refund. Failure to have the Show Puppy checked by the purchaser's Veterinarian within 48-hour period, the GUARANTEE herein would be **VOID**. Return cost of the animal is of the Buyer's expense.

This guarantee excludes death or serious faults caused by accident, virus and illnesses not contracted in sellers home or kennel.

After the 48-hour approval period **NO REFUND** of purchase price will be made for any reason.

The buyer then has the following options until the Show Puppy reaches 26 months of age. The buyer may return the Show Puppy to Tonya on exchange for another show prospect puppy, (when available) or the buyer may neuter or spay their dog (showing proof) and purchase it for Pet Puppy price of \$350 and a replacement show prospect puppy will given as soon as available, if the original Show Puppy were to:

1. Develop a disqualifying fault for the show ring according to A.K.C. Breed Standards for Rottweilers.
2. Does not pass O.F.A. certification.
3. Have a hereditary genetic disorder that causes death or serious illnesses.

YOUR GUARANTEE IS VOID AND YOUR PUPPY/DOG WILL BE CONFISCATED BY TONYA, ALSO THE OWNER OF THIS PUPPY/DOG WILL THEN SIGN OVER THE AKC REGISTRATION PAPERS TO TONYA IF THE FOLLOWING REQUIREMENTS ARE NOT MET:

1. The puppy/dog should be named with LAKEVIEW'S as the first word in its registration name.
2. If the puppy/dog is bred before its 2- years old and has not been given an OFA number.
3. If the puppy/dog is CHAINED or TIED at any time for any reason,
4. If the puppy/dog is not provided with proper shelter, shade, food and water.

If any puppy/dog receives a C.D.X. or Schh I Title from LAKEVIEW KENNEL, your next puppy/dog or stud fee is half price! If your dog is not a champion by 3-years of age and in good health, return it to Tonya and a replacement puppy/dog will be given when available. Before this replacement is valid, A professional handler must show your puppy at least 4-months or 30 shows after 2-years of age.

Any legal actions must be done in Caldwell County KY.  
This guarantee is not transferable to a subsequent buyer.
