Seller (Lil' Rascals Aussies) guarantees puppy to be healthy at time of purchase and for a 72 hour period after purchase. If puppy is greater than 8 weeks of age, vaccinations and de-worming that are appropriate for the puppy's age will have been given by seller. Buyer is required to have the puppy examined by a licensed veterinarian within 72 hours of taking possession of the puppy - failure to do so voids this contract. If it is determined by said veterinarian that the puppy has a serious illness, congenital disease, or genetic defect, buyer must notify seller immediately (this does not include abnormalities caused by injury, abuse, neglect or environmental conditions

while in the care of the buyer). In such case, buyer may return puppy to seller for a full refund of purchase price plus cost of one basic veterinary exam. If buyer wishes to return the puppy, buyer must do so within 24 hours of initial exam. If buyer chooses to keep the puppy, it is at the buyer's complete risk/expense and this contract becomes void - buyer assumes all future financial responsibility. Seller MAY choose to reduce the purchase price (issue a partial refund) of the puppy to an appropriate amount under these circumstances. If at any time during the puppy's life it is diagnosed with a serious hereditary disease, seller is to be notified immediately. In such case, buyer may return the puppy for a full refund of purchase price. If buyer chooses to keep the puppy, buyer assumes all risk/ financial responsibility and this contract becomes void - seller MAY choose to refund a reasonable portion of the purchase price. IF AT ANY TIME BUYER IS UNABLE TO CARE FOR OR KEEP THE PUPPY, SELLER MUST BE NOTIFIED IMMEDIATELY AND GIVEN FIRST RIGHT OF REFUSAL. Under no circumstances will puppy be taken to a shelter or rescue group - I will always gladly take my puppies back into my home.

The puppy is being sold as a pet/companion and is not guaranteed to possess show/breeding correctness and is not for breeding purposes. Puppy shall be spayed or neutered no later than 6 months of age - by signing below, buyer agrees to do so. Buyer also agrees to complete puppy's vaccination series by no later than 6 months of age. Failure to do either voids this contract. Although an estimate of the puppy's mature size may be given at time of sale, it is only an estimate and no guarantee is given on mature size.

Seller will provide any medical history of puppy at time of sale, including dates of vaccination and de-worming. Upon proof of puppy being spayed/neutered, seller will provide paperwork necessary for puppy's limited registration with ASDR.
